

## APPLICATION TO CHANGE LICENCE DETAILS

When applying for a licence to use or supply animals for scientific purposes, applicants are required to nominate a licence holder, contact person(s), declare designated sites where animals may be used kept or held, and an animal ethics committee (*scientific use licences only*).

Should any of these details change, licence holders are required to advise the Department of Primary Industries and Regional Development (DPIRD).

An application to change licence details must be submitted by licence holders intending to:

- change the nominated licence holder;
- add contact persons;
- add or remove designated sites registered with the DPIRD; or
- change the primary animal ethics committee responsible for overseeing the licence holders activities.
