How to complete a Re-registration or Change of Details

Prerequisite

Login to the Brands Online Portal

When logging into the Brands Online Portal, you will need to have a myGovID set up. If you do not have a myGovID already set up, instructions on **setting up your myGovID** are available online.

Part 1 – Link a Registration

To access any of your Re-registration/s or complete a Notification of Change of Address and Property Details, you first need to link your existing registration/s to your portal account.

The process to link a registration is explained below. For more detailed information, see the '*Link A Registration FAQs*' on the <u>Brands Online Portal for livestock and beekeeper</u> registrations webpage.
